The regular monthly meeting of the Calais City Council was held this date at the Calais Recreation Center on Academy Street at 6:00 p.m.

Present was Mayor Howard presiding over Councilors Moreside, Carr, Geel, Sherrard, and Rogers.

On a motion by Councilor Moreside and a second by Councilor Carr, it was unanimously voted to approve the following consent agenda as presented:

There were no Council Committee Reports

On a motion by Councilor Moreside and a second by Councilor Sherrard, it was unanimously voted to accept a \$1000.00 grant from Walmart to be used for Covid-19 issues.

It was moved by Councilor Moreside, seconded by Councilor Carr, and unanimously voted to accept Care Act Funds in the amount of \$33,790.35 from the Federal Government.

Due to Councilors not all receiving the 2018-2019 Audit by email, it was moved by Councilor Moreside, seconded by Councilor Geel, and unanimously voted to table this item until the next meeting.

It was moved by Councilor Sherrard, seconded by Councilor Rogers, and unanimously voted to authorize the deferral of payments for Economic Development Loans until things get back to normal.

On a motion by Councilor Rogers and a second by Councilor Sherrard, it was unanimously voted to waive interest charges for the time being on current sewer bills that become overdue.

It was moved by Councilor Moreside and seconded by Councilor Geel to split the charges with the Town of St Stephen for a fireworks display for International Festival if the rest of the festival has to be cancelled.

The next agenda item was a consideration of cancelling Voluntary Road Tolls for this calendar year. It was moved by Councilor Sherrard and seconded by Councilor Carr to cancel. Following some discussion, voting in favor of this motion was Councilor Sherrard, with all others were opposed. Motion failed.

It was then moved by Councilor Carr and seconded by Councilor Geel to only cancel the road tolls that are scheduled before Phase 1 of the reopening of the State by the Governor. Voting in favor were Councilors Moreside, Carr, Geel, Rogers and Mayor Howard. Councilor Sherrard was opposed. Moiton carried.

On a motion by Councilor Sherrard and a second by Councilor Rogers, it was unanimously voted to grant an abatement of Sewer Charges in the amount of \$529.38 for Acct #408.

Other items addressed with no Council action being taken at this time included:
